2024 Supreme Convention Committee Communication

The 2024 Supreme International Convention will be held at the M-Hotel (formerly Millenium Hotel) in Buffalo NY. The Executive and Advisory Board meetings will be held on Wednesday, July 17, 2024. The General Meeting will be held on July 18 & 19, 2024. There will be a banquet on Friday, July 19 and Mass on Saturday, July 20, 2024.

Per instructions from the Supreme President, Gen Frank Waseleski, Sr., due to the special circumstances post pandemic, only Delegates, Presidents and Commanders will be allowed into the meeting rooms for the General Meeting. These are special circumstances and for this convention ONLY.

Anyone else should not plan on attending as they will NOT be allowed to enter the meeting room.

The forms for registration and banquet along with information on registration at the M-Hotel are included. Note that the online registration is NOT functional at this time so the hotel must be called using our group number to reserve a room.

The Buffalo Grand Commandery looks forward to seeing our Brothers in Buffalo in July but please be patient as we are hosting with very short notice and extreme conditions.

Resolutions

Proposal to amend the Supreme Constitution of the Knights of St. John International

Whereas the Constitution of the Supreme Commandery of the Knights of St. John International was amended to include a due process procedure in the event of disputes that may arise between Commandery members (members), Members and their commandery, Members and their district, Members and their Grand Commandery, Members and their Supreme Subordinate Commandery and all of the combinations of the various commanderies, districts, grands and Supreme Subordinates; there is no formal process that can be used to remove an officer of the Supreme Commandery, if said officer is derelict or negligent in his various duties to the overall organization. This amendment addresses the process(s) and procedure(s) to be used in the event that an officer has been accused of being negligent in their duty as proscribed in the Supreme Constitution.

Therefore, this is a proposal that will add a new section under the Duties of Officers.

CHAPTER II – SUPREME COMMANDERY DISPUTE RESOLUTION INVOLVING SUPREME OFFICERS

Section 30 (New). If any officer of the Supreme Commandery is accused to be negligent, incompetent or derelict in his duties for said office, including the office of the President, the following procedure for investigation, disposition and possible administrative actions, including the potential removal from that office will be followed:

- a. A matter of serious negligence and/or incompetency must be brought forth to an officer of the Supreme Commandery by any Knight of the Order within the KSJI.
- b. The matter will be brought to the Supreme Commandery Officers. The Supreme Counsel shall lead the proceedings. (If the subject of the complaint is the Supreme Counsel, the Supreme President shall appoint an officer to lead the proceedings.) The Supreme Commandery shall decide if further investigation is necessary, to bring the matter to the Supreme Commandery. This investigation shall be conducted within 30 days of the original allegation. If more time is needed, the investigator shall request it from the Supreme Commandery. No more than an additional 30 days may be granted.
- c. If the Supreme Commandery decides to proceed with possible disciplinary actions, the officer accused of the negligence and/or incompetency will be invited to a meeting of the Supreme Commandery to discuss the matter. At the meeting if the accused officer makes a reasonable defense, as decided by the presiding officer, the Supreme Commandery can decide what actions (if any) need to be taken with a simple majority vote. If the officer does not make a reasonable defense, the Supreme Commandery can vote, with a simple majority, to present the case to the Supreme Commandery Executive Board. If the officer does not attend this meeting, the case will automatically be presented to the Supreme Commandery Executive Board.
- d. If the accused officer is the Supreme President, the Supreme 1st Vice-president will conduct the possible disposition of the case.
- e. If the case is brought to the Supreme Commandery Executive Board, the Supreme Counsel shall make the official report of the original allegation and present any evidence of the allegation(s) against him. The officer who has been accused of the allegation will be able to make a defense of the allegations against him. At that time, the Supreme Executive Board and said Officer shall field questions.
- f. Once all questions are answered, the presiding officer of the Supreme Executive Board meeting shall call for motions:
 - i. If a motion is made for sanctions/fines/suspension, the terms must be specifically outlined in the motion. This motion can be passed with a simple majority vote, where the presiding officer and accused officer shall NOT vote.
 - ii. If a motion is made for the removal from office of the officer, the motion can be passed with a 2/3rds vote, again, whereas the presiding officer and accused officer shall NOT vote.

The resolutions will define the new boards and replace all references to the Board of Trustees with the Executive Board of Directors. They will also address the expansion of the Supreme Subordinate Commanderies from two (Ghana and Nigeria) to five (Ghana, Nigeria, Sierra Leone, Liberia and the United States).

RESOLUTION 1:

BE IT RESOLVED - That the following changes be made to the Knights of St. John, International Constitution as indicated.

“The Supreme Counsel, all Past Supreme Presidents and Supreme Spiritual Director and the Grand Presidents of each Grand Commandery shall constitute the Supreme Board of Trustees of said corporation and shall hold office until their successors shall be elected and/or appointed and installed in accordance with the Constitution and By-Laws of said corporation.”

“The Supreme Executive Board of Directors of said corporation shall be composed of the elected officers, the Supreme Subordinate Presidents and all Supreme Past Presidents. The Supreme Counsel and Supreme Spiritual Director shall be considered Advisors to the Supreme Executive Board. They shall hold office until their successors shall be elected and/or appointed and installed in accordance with the Constitution and By-Laws of said corporation.

The Supreme Advisory Board of Directors of the corporation shall be composed of all Grand Commandery Presidents and Presidents of Unattached Commanderies. It will be chaired by the Immediate Past Supreme President or, if not available, a designated representative assigned by the Supreme President. (non-voting except in the case of a tie vote). The Supreme Undersecretary for the Advisory Board will act as Secretary or, if not available, another member of the Supreme Secretariat as designated by the Supreme Secretary. (non-voting) and the Supreme Counsel, when available or upon request. (non-voting)

The Supreme Executive Board of Directors will meet four (4) times a year when there is sufficient business to warrant a meeting. Quorum for the Supreme Executive Board meetings will be one-third (1/3) of the voting members of the Executive Board.

The Supreme Advisory Board meeting will be held biennial to coincide with a meeting of the

Supreme Executive Board. Quorum for the Advisory Board meetings will be one-third (1/3) of the voting members of the Advisory Board. The Advisory Board will make recommendations only to the Executive Board. The recommendations will be presented by the Chair, Secretary or a designated member of the Advisory Board. Standing Committee Chairmen, such as Supreme Undersecretaries, Inspector General, Membership Committee Chairman, etc., may bring items to the Advisory Board for discussion and inclusion with those items brought to the Executive Board. The Chair of the Advisory Board meetings will be the Immediate Past Supreme President or, if not available, a designated representative assigned by the Supreme President. The Secretary for the Advisory Board meetings will be the Supreme Undersecretary for the Advisory Board or, if not available, a member of the Supreme Secretariat assigned by the Supreme Secretary. These members will not have a vote except for the Chair, who will have a vote in case of a tie. The Supreme Counsel will attend the Advisory Board meeting if it does not conflict with the Executive Board meeting but will be available if needed. The Counsel will not have a vote within the proceedings.”
